**Basic Benefits:** Part A coinsurance plus coverage for 365 additional days after Medicare benefits end.  
Hospitalization: Part B coinsurance (generally 20% of Medicare-approved expenses) or copayments for hospital outpatient services. Plans K, L, and N  
Medical Expenses: require insureds to pay a portion of Part B coinsurance or copayments.  
Blood: First 3 pints of blood each year.  
Hospice: Part A coinsurance.

These expenses include the Medicare deductibles for Part A and Part B, but do not include the plans' separate foreign travel emergency deductible.

**Policy Replacement**

If you are replacing another health insurance policy, do NOT cancel it until you have actually received your new policy and are sure you want to keep it.
